# My course has been over-enrolled beyond the course cap without my permission. What should I do?

You should notify your respective chair and dean if your course has been over-enrolled without your permission, and copy that notification to AAUP-UC Grievance Officer Kirstin Walker (kfwalker@utica.edu).

### What do I do if I am being pressured to over-enroll my course?

If you are being pressured to over-enroll your course, email any member of the governing board and/or Grievance Officer Kirstin Walker.

## I've earned a lot of NTTs credits over the past few semesters. Do they expire?

No. If you retire, however, you may only cash out up to a maximum 45 NTT credits (i.e., the equivalent of a 3-credit course overload). You cannot cash out more than 45 NTT credits when you retire. So, it is best to plan how you wish to use your NTT credits before you retire.

# I don't want to include my Fall 2021 SOOTs in my file. What is the deadline for me to exclude my Fall 2021 SOOTs?

The deadline to exclude your Fall 2021 Student Opinionnaires on Teaching (SOOTs) from any future materials for consideration of reappointment, tenure, promotion, and/or professional development evaluation procedure, is Tuesday, February 15, 2022. If you wish to exclude your Fall 2021 SOOTS from all future evaluation processes, please notify your school dean via email by Tuesday, February 15, 2022. We recommend you also copy that message to Adam Pack (apack@utica.edu).

#### Did the amount I can contribute to my HSA go up?

Yes! You can now contribute a maximum of \$3650 for a single account or \$7300 for a family account. You can increase your contribution at any point using the HSA contribution form available from the Human Resources Office, and attached to this email.

#### Should I put our next General Membership meeting on my calendar?

Yes! Our next General Membership meeting is scheduled for **February 23, 2022**, from 3:30pm-5:30pm. More information about this meeting, which will be held virtually, will be sent out soon. Per the collective bargaining agreement, the College may not schedule any meetings that require the attendance of bargaining unit members during this time. If you are asked to attend a meeting during this time, please let Adam Pack and/or Kirstin Walker know.

# I wasn't able to meet with a board member for an office visit or I haven't been contacted yet. Can I still schedule an office visit with a board member?

These vehicles are made in the United States or Canada by members of the UAW and Canada's Unifor union, formerly the Canadian Auto Workers (CAW). Because of the integration of vehicle production in both countries, all of the vehicles listed as made in Canada include significant UAW-made content and support the jobs of UAW members.

However, vehicles marked with a single asterisk (\*) are also produced in Mexico.

All heavy-duty Chevrolet Silverados and GMC Sierras will be built in Flint, Michigan, only. Light-duty Chevrolet Silverado and GMC Sierra regular cabs are produced in Mexico only. Vehicles marked with a double asterisk (\*\*) are the crew cab versions of the Chevrolet Silverado light-duty and GMC Sierra light-duty trucks. Those are assembled by UAW members in Fort Wayne, Indiana,

When purchasing a vehicle marked with a single or double asterisk, it's important to check the Vehicle Identification Number (VIN). A VIN beginning with "1" or "4" or "5" identifies a U.S.-made vehicle; a "2" identifies a Canadian-made vehicle; a "3" identifies a vehicle made in Mexico. Not all vehicles made in the United States or Canada are built by union-represented workers. Vehicles not listed here, even if produced in the United States or Canada, are not union made.
